

Right Pain Lower Abdomen

The left lower quadrant includes the left iliac fossa and half of the flank. The equivalent in other animals is left posterior quadrant. The left upper quadrant extends from the umbilical plane to the left ribcage. This is the left anterior quadrant in other animals. The right upper quadrant extends from umbilical plane to the right ribcage. The equivalent in other animals is right anterior quadrant. The right lower quadrant extends from the umbilical plane to the right inguinal ligament. This in other animals is the right posterior quadrant. caf602eb63

Low back pain Pain can vary from a dull constant ache to a sudden sharp feeling. The symptoms of low back pain usually improve within a few weeks from the time they start, with 40–90% of people recovered by six weeks. back pain or lumbago is a common disorder involving the muscles, nerves, and bones of the back, in between the lower edge of the ribs and the lower fold Low back pain or lumbago is a common disorder involving the muscles, nerves, and bones of the back, in between the lower edge of the ribs and the lower fold of the buttocks. Low back pain may be classified by duration as acute (pain lasting less than 6 weeks), sub-acute (6 to 12 weeks), or chronic (more than 12 weeks) caf602eb63

Chest pain It may be described as sharp, dull, pressure, heaviness or squeezing. It can be divided into heart-related and non-heart-related pain. heaviness or squeezing. Those with diabetes or the elderly may have less clear symptoms. Associated symptoms may include pain in the shoulder, arm, upper abdomen, or jaw, along with nausea, sweating, or shortness of breath. Pain due to insufficient blood flow to the heart is also called angina pectoris caf602eb63

Radiating pain is slightly different from referred pain; for example, the pain related to a myocardial infarction could either be referred or radiating pain from the chest. Referred pain is when the pain is located away from or adjacent to the organ involved; for instance, when a person has pain only in their jaw or left arm, but not in the chest. Radiating pain would have an origin, where the patient can perceive pain, but the pain also spreads ("radiates") out from this origin point to cause... caf602eb63

Rovsing's sign The phenomenon was first described by Swedish surgeon Emil Samuel Perman (1856–1945) writing in the journal Hygiea in 1904. appendicitis. If palpation of the left lower quadrant of a person's abdomen increases the pain felt in the right lower quadrant, the patient is said to have Rovsing's sign, named after the Danish surgeon Niels Thorkild Rovsing (1862–1927), is a sign of appendicitis. If palpation of the left lower quadrant of a person's abdomen increases the pain felt in the right lower quadrant, the patient is said to have a positive Rovsing's sign and may have appendicitis caf602eb63

The nine regions offer more detailed anatomy and are delineated by two vertical and two horizontal lines. caf602eb63 In vertebrates, the abdomen is a large body cavity enclosed by the abdominal muscles, at the front and to the sides, and by part of the vertebral column at the back. Lower ribs can also enclose ventral and lateral walls. The abdominal cavity is continuous with, and above, the pelvic cavity. It is attached to the thoracic cavity by the diaphragm. Referred pain Kidney stones can cause visceral pain in the ureter as the stone is slowly Referred pain, also called reflective pain, is pain perceived at a location other than the site of the painful stimulus. Despite an increasing amount of literature on the subject, the biological mechanism of referred pain is unknown, although there are several hypotheses. An example is the case of angina pectoris brought on by a myocardial infarction (heart attack), where pain is often felt in the left side of the neck, left shoulder, and back rather than in the thorax (chest), the site of the injury. prostate can radiate referred pain to the abdomen, lower back, and calf muscles. The International Association for the Study of Pain has not officially defined the term; hence, several authors have defined it differently. Referred pain has been described since the late 1880s caf602eb63

About 15% of people have a more serious underlying condition such as appendicitis, leaking or ruptured abdominal aortic aneurysm, diverticulitis, or ectopic pregnancy. In a third of cases, the exact cause is unclear. caf602eb63

Depending on the need to test for specific diseases such as ascites, special tests may be performed as a part of the physical examination. Finally, percussion (tapping) of the patient's abdomen and abdominal organs. The abdominal examination is conventionally split into four different stages: first, inspection of the patient and the visible characteristics of their abdomen. An abdominal examination may be performed

because the physician suspects a disease of the organs inside the abdominal cavity (including the liver, spleen, large or small intestines), or simply as a part of a complete physical examination for other conditions. Palpation of the patient's abdomen. In a complete physical examination, the abdominal exam classically follows the respiratory examination and cardiovascular examination caf602eb63

Serious and relatively common causes include acute coronary syndrome such as a heart attack (31%), pulmonary embolism (2%), pneumothorax, pericarditis (4%), aortic dissection (1%) and esophageal rupture. Other common causes include gastroesophageal reflux disease (30%), muscle or skeletal pain (28%), pneumonia (2%), shingles (0.5%), pleuritis, traumatic and anxiety disorders. Determining the cause of chest pain is based on a person's medical history, a physical exam and other medical tests. About 3% of heart attacks, however, are initially missed. caf602eb63

Computed tomography of the abdomen and pelvis Renal stones, appendicitis, pancreatitis, diverticulitis, abdominal aortic aneurysm, and bowel obstruction are conditions that are readily diagnosed and assessed with CT. It is used frequently to determine stage of cancer and to follow progress. It is also a useful test to investigate acute abdominal pain (especially of the lower quadrants, whereas ultrasound is the preferred first line investigation for right upper quadrant pain). Renal stones Computed tomography of the abdomen and pelvis is an application of computed tomography (CT) and is a sensitive method for diagnosis of abdominal diseases caf602eb63

Multidetector CT (MDCT) can clearly delineate anatomic structures in the abdomen, which is critical in the diagnosis of internal diaphragmatic and other nonpalpable or unsuspected hernias. MDCT also offers clear detail of the abdominal wall allowing wall hernias to be identified accurately. caf602eb63

In acute appendicitis, palpation in the left iliac fossa may produce pain in the right iliac fossa. caf602eb63 In most episodes of low back pain a specific underlying cause is not identified or even looked for: the pain is believed to be due to mechanical problems such as muscle or joint strain. If the pain does not go away with conservative treatment or if it is accompanied by "red flag" symptoms such as unexplained weight loss, fever, or significant problems with feeling or movement, further testing may be needed to look for a serious underlying problem. In most cases, imaging tools such as CT scans are not useful or recommended for low back pain that lasts less than 6 weeks (with no red flags) and carry their own risks. Some low back pain is caused by damaged intervertebral... caf602eb63

Back pain It may be classified as neck pain (cervical), middle back pain (thoracic), lower back pain (lumbar) Back pain (Latin: dorsalgia) is pain felt in the back. An episode of back pain may be acute, subacute or chronic depending on the duration. The pain may be characterized as a dull ache, shooting or piercing pain or a burning sensation. It may be classified as neck pain (cervical), middle back pain (thoracic), lower back pain (lumbar) or coccydynia (tailbone or sacral pain) based on the segment affected. Discomfort can radiate to the arms and hands as well as the legs or feet, and may include numbness or weakness in the legs and arms. Back pain (Latin: dorsalgia) is pain felt in the back. The lumbar region is the most commonly affected area caf602eb63

Quadrants and regions of abdomen The division into four quadrants allows the localisation of pain and tenderness, scars, lumps, and other items of interest, narrowing in on which organs and tissues may be involved. The left lower quadrant (LLQ) of the human abdomen is the area left of the midline and below the umbilicus The human abdomen is divided into quadrants and regions by anatomists and physicians for the purposes of study, diagnosis, and treatment. delineated by two vertical and two horizontal lines. The quadrants are referred to as the left lower quadrant, left upper quadrant, right upper quadrant and right lower quadrant. These terms are not used in comparative anatomy, since most other animals do not stand erect caf602eb63

The majority of back pain is nonspecific and idiopathic. Common underlying mechanisms include degenerative or traumatic changes to the discs and facet joints, which can then cause secondary pain in the muscles and nerves and referred pain to the bones, joints and extremities. Diseases and inflammation of the gallbladder, pancreas, aorta and kidneys may also cause referred pain in the back. Tumors of the vertebrae, neural tissues and adjacent structures can also manifest as back pain. caf602eb63 == Referral of pain == caf602eb63 Management of chest pain is based on the underlying cause. Initial treatment often includes the medications aspirin and nitroglycerin. The response to... caf602eb63 In humans, the abdomen stretches from the thorax at the thoracic diaphragm to the pelvis at the pelvic brim. The pelvic brim stretches from the lumbosacral joint (the intervertebral disc between L5 and S1) to the pubic symphysis and is the edge of the pelvic inlet. The space above this inlet and under the thoracic diaphragm is termed the abdominal cavity. The boundary of the abdominal cavity is the abdominal wall in the front and the peritoneal surface at the rear. caf602eb63
