The first area code split became necessary in 1951, when most of the southern and eastern portion, including San Diego and most of Orange County, was assigned area code 714. In 1982, 714 was split and almost all of the southernmost portion of California, from San Diego to the Nevada border received area code 619, the first new area code in California since 1959, when 707 was added. 6230c405e1 Area code 760 was split from 619 in 1997, and 619 had been split from area code 714 in 1982. Within a decade of creation, the proliferation of cell phones and pagers left area code 760 under the threat of exhausting its central office prefixes. The initial relief plan was another area code split, with the San Diego and Imperial areas moving to a new 442 area code. However, this met with protests from businesses who did not want to change their numbers for the second time in a decade.
