In the mid-20th century, urban planning experts such as Jane Jacobs called on urban planners to take resident experiences and needs more into consideration. Over time, urban planning has adopted a focus on the social and environmental "bottom lines" that focus on using planning as a tool to improve the health and well-being of people and maintain sustainability standards. Traditionally, urban planning followed a top-down approach in master planning the physical layout of human settlements.
