Most laws apply only to drinking alcohol in public places with alcohol consumption in the home being mostly unregulated (one of the exceptions being England and Wales, which have a minimum legal age of five for supervised consumption in private places). These laws vary between countries and many laws have exemptions or special circumstances, up to no laws about consumption at all.
