The boreal region in Canada covers almost 60% of the country's land area. Other countries with boreal forest include Russia, which contains the majority; the

United States in its northernmost state of Alaska; and the Scandinavian or Northern European countries (e. For regression Random forests or random decision forests is an ensemble learning method for classification, regression and other tasks that works by creating a multitude of decision trees during training. multitude of decision trees during training. Random forests correct for decision trees' habit of overfitting to their training set. For regression tasks, the output is the average of the predictions of the trees. The extension combines Breiman's "bagging" idea and random selection of features, introduced first by Ho and later independently by Amit and Geman in order to construct a collection of decision trees with controlled variance.

By 1283 the forest was fenced in by a 23 miles (37 km) pale enclosing an area of 20 square miles (52 km²; 13,000 acres; 5,200 ha). Thirty-four gates and hatches in the pale, still remembered in place names such as Chuck Hatch and Chelwood Gate, allowed local people to enter to graze their livestock, collect firewood, and cut heather and bracken for animal bedding. The forest continued to be used by the monarchy and nobility for hunting into Tudor times, including notably Henry VIII, who had a hunting lodge at Bolebroke Castle, Hartfield and who courted Anne Boleyn at nearby Hever Castle. d847087d6e evidence about important historic events or persons from the national history. d847087d6e Sherwood Forest is within an area which used to be called "Birch Lund", which is Viking in origin, now known as Birklands. d847087d6e Today, Sherwood Forest National Nature Reserve encompasses 424.75 hectares

(1,049.6 acres), surrounding the village of Edwinstowe and the site of Thoresby Hall. The reserve contains more than a thousand ancient oaks which are known to be more than 500 years old, with the Major Oak being twice that age.

Its name is derived from its status as the shire (or sher) wood of Nottinghamshire, which extended into several neighbouring counties (shires), bordered to the west by the River Erewash and the Forest of East Derbyshire. d847087d6e The once vast estate was centred on Dartrey House which was demolished in 1946. The forest's main gate is only a few miles from Cootehill. It is currently managed by Coillte as a commercial forest. The Forest is partially bordered by what is known locally as 'the Famine Wall', which stretches halfway along the road from Cootehill to Rockcorry (the R188). Just across the R188, the main Cootehill to Rockcorry road, near the main gate into the forest, is the Dawson Monument, a fine neo-Classical column designed by James Wyatt and erected around 1808. The net area of primary forest has decreased by 1.3 million square kilometers (4.4 million square miles) of primary forest remaining. The concept of diverse tree structure includes multi-layered canopies and canopy gaps, greatly varying tree heights and diameters, and diverse tree species and classes and sizes of woody debris.
