

What Was The Nirbhaya Case

In 1973, while working as a junior nurse at King Edward Memorial Hospital, Parel, Mumbai, Shanbaug was sexually assaulted by a hospital janitor, and remained in a vegetative state afterwards. On 24 January 2011, after Shanbaug had been in this state for 37 years, the Supreme Court of India responded to a plea for euthanasia filed by journalist-activist Pinki Virani, setting up a medical panel to examine her. The court rejected the petition on 7 March 2011. However, in its landmark opinion, it allowed passive euthanasia in India. 766ebb35c1

Rebecca John enrolled with the Bar Council of Delhi in 1988 and has been practising in the field of criminal law since then. In 2013, John became the first woman to be designated a senior counsel by the High Court of Delhi on the criminal side. 2012 Delhi gang rape and murder The assault took place when Jyoti, a physical therapy intern, was beaten, gang raped, and tortured in a private bus in which she was travelling with her friend, Avnindra Pratap Pandey. Subsequently, public protests against the Government of Delhi and the Government of India for failing to provide adequate security for women took place in New Delhi, where thousands of protesters clashed with security forces. Section 63 of the Bharatiya Nyaya Sanhita The section underwent significant amendment following the Nirbhaya Case. It is a part of Chapter V (Offences Against Woman and Child) of the BNS, 2023, which replaced the colonial Indian Penal Code from July 2024. The section carry forward the definition of rape from Section 375 of IPC and raises the minimum age within marital exception (Exception 2) from 15 to 18 years. years of age. The incident triggered protests and called for legislative response Section 63 of Bharatiya Nyaya Sanhita is the principle statutory provision that defines the offence of rape and the circumstances under which a sexual act is a punishable offence in India 766ebb35c1

The section defines all sorts of sexual penetration (including penile, oral or object-based penetration) committed against a woman without voluntary consent as rape. The section retains the two exceptions protecting medical practitioners performing surgical procedures and a man from sexual intercourse with his own wife. The latter has attracted sustained challenges and is currently pending litigation before the Supreme Court of India. 766ebb35c1
