Orissa famine of 1866 Timeline of major famines in India during The Orissa famine of 1866 affected the east coast of India from Madras northwards, an area covering 180,000 miles and containing a population of 47,500,000; the impact of the famine, however, was greatest in the region of Orissa, now Odisha, which at that time was quite isolated from the rest of India. Construction of the canal started during 1880 and the canal was fully opened for traffic in 1888. In Odisha, the total number of deaths as a result of the famine was at least a million, roughly one third of the population. West Bengal b3bad9c811

The famine was initially triggered by a severe drought following the failure of the southwest monsoon in 1865, which devastated the region's winter rice crop. However, modern historians largely attribute the catastrophic mortality rate to the colonial administration's strict adherence to laissez-faire economic policies and administrative negligence.

The year 1765 is chosen as the start year because that year the British East India Company, after its victory in the Battle of Buxar, was granted the Diwani (rights to land revenue) in the region of Bengal (although it would not directly administer Bengal until 1784 when it was granted the Nizamat, or control of law and order.) The year 1947 is the year in which the British Raj was dissolved and the new successor states of Dominion of India and Dominion of Pakistan were established. The eastern half of the Dominion of Pakistan would become the People's Republic of Bangladesh in 1971.

Eventually, families disintegrated; men sold their small farms and left home to look for work or to join the British Indian Army, and women and children became homeless migrants, often travelling to Calcutta or other large cities in search of organised relief. Millions were impoverished as the crisis overwhelmed large segments of the economy and catastrophically disrupted the social fabric

Indian agriculture is heavily dependent on climate: a favorable southwest summer monsoon is critical in securing water for irrigating crops. Droughts, combined with policy failures, have periodically led to major Indian famines, including the Bengal famine of 1770, the Chalisa famine, the Doji bara famine, the Great Famine of 1876–1878, and the Bengal famine of 1943. Some commentators have identified British government inaction as a contributing factor to the severity of famines during the British rule in India. Famines in the

The famine ultimately affected an area of 670,000 square kilometres (257,000 sq mi) and caused distress to a population totalling 58,500,000. Although the region still produced foodstuffs sufficient to avoid famine, colonial grain exports swelled to record numbers, ensuring widespread devastation. The famine is also known as the Southern India famine of 1876–1878 and the Madras famine of 1877. It began in 1876 after an intense drought resulted in crop failure in the Deccan Plateau.

Bengal's economy had been predominantly agrarian at that time, with between half and three-quarters of the rural poor subsisting in a "semi-starved condition". Stagnant agricultural productivity and a stable land base were unable to cope with a rapidly increasing population, resulting in both long-term decline in per capita availability of rice and growing numbers of the land-poor and landless labourers... Despite widespread crop failures, the Bengal Board of Revenue, led by Lieutenant-Governor Cecil Beadon, refused to intervene in the grain market. Guided by Malthusian principles, officials believed that free trade would naturally correct shortages and that government intervention would be inherently harmful. During the early months of the scarcity, India exported over 200 million pounds of rice to Britain... The Bengal Presidency emerged from trading posts established in the Bengal Subah of Mughal Empire, during the reign of Emperor Jahangir in 1612. The East India Company (EIC), a British

Indian monopoly with a royal charter, competed with other European companies to gain influence in Bengal. In 1757 and 1764, the company defeated the Nawab of Bengal, who acted on Mughal sovereignty, at the Battle of Plassey and the Battle of Buxar, and Bengal came under British influence. Crop failure in autumn 1768 and summer 1769 and an accompanying smallpox epidemic were thought to be the manifest reasons for the famine. The East India Company had farmed out tax collection on account of a shortage of trained administrators, and the prevailing uncertainty may have worsened the famine's impact. Other factors adding to the pressure were: grain merchants ceased offering grain advances to peasants, but the market mechanism for exporting the merchants' grain to other regions remained in place; the East India Company purchased a large portion of rice for its army; and the Company's private servants and their... b3bad9c811

In the early months of the famine, the government applied pressure on newspapers to "calm public fears about the food supply" and follow the official stance that there was no rice shortage. This effort had some success; The Statesman published editorials asserting that the famine was due solely to speculation and hoarding, while "berating local traders and producers, and praising ministerial efforts." News of the famine was also subject to strict

war-time censorship – even use of the word "famine" was prohibited – leading The Statesman later to remark that the UK government "seems virtually to have withheld from the British public... b3bad9c811

Bengal Presidency Colonial India as well as the Bengal Presidency suffered from the numerous famines and epidemics throughout the British Rule. Bengal proper covered the ethno-linguistic region of Bengal (present-day Bangladesh and the Indian state of West Bengal). Calcutta, the city which grew around Fort William, was the capital of the Bengal Presidency. For many years, the governor of Bengal was concurrently the governor-general of India and Calcutta was the capital of India until 1911. The Great Bengal famine of 1770 The Bengal Presidency, officially the Presidency of Fort William in Bengal until 1937, later the Bengal Province, was the largest of all three presidencies of British India during Company rule and later a province of British Raj.
