Pregnancy from rape It has been studied in the context of war, particularly as a tool for genocide, as well as in other unrelated contexts, such as rape by a stranger, statutory rape, incest, and underage pregnancy. The scientific consensus is that rape is at least as likely to lead to pregnancy as consensual sexual intercourse, with some studies suggesting rape may actually result in higher rates of pregnancy than consensual intercourse. Gray rape is dubious, ambiguous or inadequately established and does not meet the legal definition of rape. The term "gray rape" has been criticized. The term was popularized by Laura Sessions Stepp in her Gray rape, also spelled as grey rape, is a colloquial description of sexual intercourse for which consent is dubious, ambiguous or inadequately established and does not meet the legal definition of rape. Lisa Jervis, founder of Bitch magazine, argued that gray rape and date rape "are the same thing" and that the popularization of the gray rape concept constituted a backlash against women's sexual empowerment and risked rolling back the gains women had made in having rape taken seriously. The term was popularized by Laura Sessions Stepp in her viral 2007 Cosmopolitan article "A New Kind of Date Rape", which says gray

rape is "somewhere between consent and denial and is even more confusing than date rape because often both parties are unsure of who wanted what" ac86e8c065

Extensive research has been conducted about types, acceptance, and impact of rape myths. Rape myths significantly influence the perspectives of jurors, investigative agencies, judges, perpetrators, and victims. False views about rape lead to victim blaming, shaming, questioning of the victim's honesty, and other problems. Determination of the guilt of the accused, and sentencing for sexual crimes, are also influenced by these beliefs. ac86e8c065 Rape can cause difficulties during and after pregnancy, with potential negative consequences for both the victim and a resulting child. Medical treatment following a rape includes testing for, preventing, and managing pregnancy. A woman who becomes pregnant after a rape may face a decision about whether to have an abortion, to raise the child, or to make an adoption plan. A feature of date rape is that most victims are women, who know the perpetrators. The rape occurs when there is an actual or a potential romantic or sexual relationship, or when the relationship has come to an end. Laws are rarely enforced, due to factors ranging from reluctance of authorities to pursue the crime, to lack of public knowledge that sexual intercourse in marriage without consent is illegal. ac86e8c065 The notion of rape culture was developed by second-wave feminists, primarily in the United States, beginning in the 1960s. In Europe, from medieval times well into the 18th century, a man could use a woman's pregnancy as a legal defense... ac86e8c065 Until well into the 20th century, academic consensus did not view the Hebrew Bible as containing acts of rape, that is, sexual actions performed without the consent of a participant, apart from the rape of Tamar in 2 Samuel 13. Some narratives such as those of Samson and Delilah (Judges 16) and Shechem and Dinah (Genesis 34) were even interpreted to be love stories (e.g. about elopement) rather than rape stories. An example of a rare exception to this is a claim by Thomas Paine, who asserted in *The Age of Reason* (1795) that Numbers 31 portrayed Moses as ordering the Israelites to kill all Midianites except the virgin girls, whom they could keep for what Paine termed "debauchery": "Among the detestable villains that in any period of the world would have disgraced the name of man, it is impossible to find a greater than Moses, if this account be true. Here is an order to butcher the boys, to massacre the mothers, and debauch the daughters." This is a heavily disputed and controversial claim, as it goes directly against the current consensus that rape is emotionally and culturally motivated. Sociobiological theories of rape became more common as the women's rights movements increased in relevance during the 1970s,

which implies that the popularity of the area may be political in nature. ac86e8c065 Rape myths originate from various cultural stereotypes, such as traditional gender roles, acceptance of interpersonal violence, and misunderstanding the nature of sexual assault. Matthew Hale, a British jurist in the 17th century, suggests that rape is "an accusation easily to be made and hard to be proved and harder to be defended against by the party accused, tho [sic] never so innocent". His historical thoughts invisibly support many rape myths seen today, and continue to be reproduced in rape trials.... ac86e8c065
